Upon receipt of a complete application and the application fee, the Licensing-Revenue Officer shall give copies of the application to the Police Chief, the Health Officer, the Director of Public Services, and the Community Development Director, who shall investigate the matter and report in writing to the Licensing-Revenue Officer not later than thirty (30) days prior to the event with appropriate recommendations concerning the activity. The Licensing-Revenue Officer shall also provide a copy of the complete application to the members of the City Council.
TITLE IX CHAPTER 92 Outdoor Festivals, Sec. 92.02 Licenses: Required: Applications
It shall be unlawful for any person to operate, maintain, conduct, advertise, sell, or furnish tickets or other types of written authority for admission to an outdoor festival in the City unless he shall first obtain a license from the city to operate or conduct such festival, which license shall be in addition to any business license issued pursuant to the provisions of Chapter 33 of the Title III of this code.
Applications for licenses to conduct outdoor festivals shall be made in writing to the Licensing-Revenue Officer, shall be accompanied by a nonrefundable application fee of One Hundred and no/100th (\$100,00) Dollars to be filed with the Licensing-Revenue Officer.
